It is a pleasure to present the Arts Industry Council (SA) Inc. (AIC) Chair's report for 2009. The year was a constructive one for the AIC with a program of activities delivered in pursuit of our aim to be *an independent voice* for the arts in South Australia. The AIC continues to advocate at State and Federal levels for the arts to be recognised as an essential, creative and dynamic force in Australian society.

As a state-based sector-wide representative organisation, the AIC relies on membership fees, fundraising and the voluntary time contributed by its Committee to operate independently. The AIC doesn't seek government funding. Advocacy activities are supported by an Executive Officer who works approximately one day per week for the organisation.

- held on 23 October a Fundraising Event at the Rob Roy hotel where we had dinner and guest speaker, Andrew Wallace spoke about the Laneways project in the West End of the City.
