# 5. Financial Report as of 31 Dec 2019

The Executive Officer presented the 2019 Financial Reports and noted an increase in membership fees up from \$15,665 in 2018 to \$17,860 in 2019. This is due to a slight raise in membership annual fees and also to new members joining.

The organisation ended the year with a surplus of \$1,165 and Total Equity of \$18,028.

THE ARTS INDUSTRY COUNCIL (SOUTH AUSTRALIA) INC hereby seeks to make the following amendments to its Constitution. In order to bring the Constitution in line with current accepted pronouns, to correct spelling errors and to update membership and Executive Committee guidelines.

In like with AICSA's Constitution, the constitution may be amended by a resolution at a General Meeting of the Council which is passed by a majority of at least two thirds of the members present in person or by proxy and entitled to vote at a General Meeting. Members will be asked to vote to approve these amendments.

#### **Amendment One**

Remove gendered pronouns throughout the Constitution and where there is reference to 'his', 'her' or 'she' update to the neutral 'their' or 'they'.

#### **Amendment Two**

Note: Membership is currently open to all individuals and organisations who support the organisation and there is no requirement to make an application directly to the Executive.

5.1 Members of the Council shall be those organisations or individuals who support the objects of the Council and who are admitted to membership by the Executive. Admission to membership shall be solely at the discretion of the Executive.

#### Amend to

5.1 Members of the Council shall be those organisations or individuals who support the objects of the Council.

#### **Amendment Three**

Note: Recommend to update this clause so that all nominations to the Executive are made from Individual financial members and not as representatives of organisations, in order to avoid conflict of interest.

5.3 Organisational members shall nominate in writing a representative who shall be eligible to vote in General Meetings and shall be eligible for election to the Executive.

#### Amend to

5.3 Organisational members shall nominate in writing a representative who shall be eligible to vote in General Meetings.

#### **Amendment Four**

Note: It is currently not a requirement for members to resign in writing.

Delete 5.5

5.5 A member may resign from membership of the Council by giving written notice to the Chairperson or Public Officer of the Council.

#### **Amendment Five**

Note: This clause clarifies the process for nominating Life Members.

Add new clause 5.5

5.5 From time to time the Executive shall nominate individuals who have provided exceptional service to the Council to be Life Members who will be exempt from paying annual membership fees.

#### **Amendment Six**

This clarifies AICA's board composition can include three co-opted positions to a total of 13 members

7.3 The Executive shall consist of up to 10 members elected at the Annual General Meeting in accordance with clause 7.4.

#### Amend to

7.3 The Executive shall consist of up to 10 members elected at the Annual General Meeting in accordance with clause 7.4 or 10 elected members and up to 3 co-opted members in accordance with clause 7.7.

#### **Amendment Seven**

Note: This clarifies that nominations shall be from Individual Financial members and not representative of an organisation.

7.5 Candidates for election to the Executive shall be nominated in writing by two financial members of the Council, and shall consent in writing to the nomination. Nominations must be received before the start of the Annual General Meeting.

#### Amend to

7.5 Candidates for election to the Executive shall be financial Individual members and shall be nominated in writing by two financial members of the Council. The candidate shall consent in writing to the nomination.

Nominations must be received before the start of the Annual General Meeting.

### **Amendment Eight**

Note: This clause is redundant.

#### Delete

7.8 At the Annual General meeting of 2001, five positions on the Executive shall be vacant. These shall be the positions of those members not wishing to stand for re-election, with the balance drawn by lot from the remaining executive members.

#### **Amendment Nine**

Note: In line with updates to pronouns throughout the Constitution.

#### 20. INTERPRETATION

In this constitution, except where the context requires otherwise, words implying the singular shall include the plural, words implying the feminine shall include the masculine, and words implying human persons shall include firms, associations and other bodies corporate and unincorporated.
